## ***The UUSC Link***

The UUSC is an independent human rights organization, supported through the volunteer efforts and financial gifts of its members and supporters, and linked to UU congregations through local representatives. The four focus areas of its work include: *Rights in Humanitarian Crises; Civil Liberties; Economic Justice; Environmental Justice*. On Sunday, April 10, the Mt Vernon UUF celebrated Justice Sunday, highlighting the *Rights in Humanitarian Crisis* work of the UUSC. This month, I would like to inform you about one facet of UUSC's work in the *Environmental Justice* focus area.

Perhaps you heard about the “fracking” (hydraulic fracturing) accident that occurred in Pennsylvania in April? The controversial practice, essential to the extraction of natural gas from shale, involves pumping up to a million gallons of water treated with biocides, lubricants, surfactants and stabilizers a mile or more into the ground at pressures exceeding 9000 psi. The April spill is the latest and possibly the most serious fracking accident in the controversial seven-year hunt to unleash natural gas from the Marcellus Shale, the biggest natural gas fracking target in the U.S., which underlies large parts of Ohio, Pennsylvania, West Virginia and New York.

UUSC is supporting legislation to repeal the exemption from regulation of hydraulic fracturing that is contained in the Safe Water Drinking Act. The exemption, passed in 2005, ignores mounting evidence that fracking poses a serious threat to drinking-water sources and to human health. The *Fracturing Responsibility and Awareness of Chemicals (FRAC) Act of 2011* would make it law that corporations involved in hydraulic fracturing must disclose all chemicals used in fracking operations, with the exception of proprietary information. As part of its shareholder-advocacy program, UUSC has co-filed shareholder resolutions with ExxonMobil and Chevron, requesting that they disclose known and potential environmental impacts of their fracturing operations to the public. The resolutions also urge that policy options above and beyond regulatory requirements and existing efforts be adopted to reduce or eliminate hazards to air, water, and soil quality from fracturing operations.

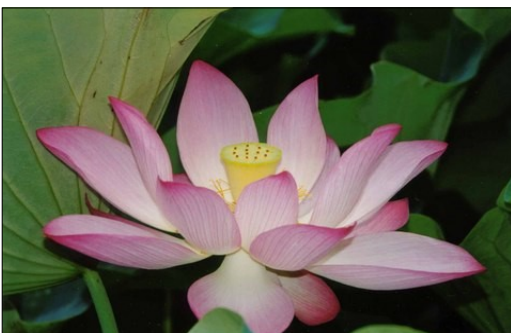
Nancy has one brother, Steve Blagg. Steve has one daughter, Stephanie, and one son, John. They all reside in Las Vegas.

# Call for Volunteers!

Dear fellow MVUUF members,

All five positions on the Board of Trustees are up for election at the May 15, 2011, annual membership meeting. As many of you know, Shannon and I will be moving this summer, so I will not be running again under any circumstances. After four consecutive, one-year terms, I think it is best to bring in newer members to serve anyway. I encourage any member who has never served on the Board of Trustees to seriously consider doing so now!

The term of anyone elected to the Board at the May 15, 2011, meeting will begin on July 1, 2011 and will last until June 30, 2012. Anyone interested in running should look over Articles VII and VIII of the Bylaws, which deal specifically with the Board.

In short, and in general, the Board meets once a month and handles any fellowship issues that arise, as well as regular business. Currently, the Board meets on the first Wednesday of each month at 6:30 pm, though that could be changed by the new Board, as long as members were kept informed ahead of time (at least 5 days, per the Bylaws) of when meetings were to occur. Here is a brief description, from the Bylaws, of the responsibilities of each Board position:

**Co-chairs (3):** preside at all membership meetings and all meetings of the Board of Trustees. Any one of the three Co-chairs may sign, with the Secretary or Treasurer, instruments on behalf of the Fellowship and, in general, shall perform all the duties incident to the office of chief executive officer and such other duties as may be prescribed by the Fellowship or the Board of Trustees from time to time.

**Secretary (1):** keep the minutes of the meetings of the membership and of the Board of Trustees, see that all notices are duly promulgated, be the custodian of the Fellowship records, and in general perform all the duties incident to the office of Secretary and such other duties as from time to time may be assigned by the Board of Trustees.

**Treasurer (1):** have charge and custody of and be responsible for all the funds of the Fellowship, receive and give receipts for the monies of the Fellowship from any source and deposit all such monies in the name of the Fellowship in such financial institutions as agreed by the Board of Trustees, shall pay from available funds the obligations of the Fellowship, and in general perform all the duties incident to the office of Treasurer and such other duties as from time to time may be assigned by the Board of Trustees.

Between meetings, the current Board sometimes communicates about issues via email. By doing this ahead of time, meetings tend to run more smoothly. Typical recent Board meetings last between 45 minutes and 1 hour per month. Three or four emails per month is the current typical amount of between-meeting traffic.

If you have any questions about Board service, please contact me or another Board member.

If you wish to be placed on the ballot for a position on the Board, please contact me, indicating whether there is a particular position in which you would like to serve, or if you are willing to serve in whatever way is available.
