## *Member News*

MVUUF member Adam E. Stone's spoken-word ballet "A Life Unhappening," which examines the impact of Alzheimer's disease on three generations of one woman's family, will be performed three times in our area.

A special preview performance will be held at Shryock Auditorium in Carbondale, Illinois on Friday, May 4, 2012 at 7:30 pm, with proceeds from the performance to benefit the Greater Illinois Chapter of the Alzheimer's Association. The World Premiere performance will be held at the Blanche M. Touhill Performing Arts Center in St. Louis, Missouri on Friday, May 11, 2012. A wine and cheese reception will begin at 6:30 pm, with the performance to follow at 7:30 pm. The performance will be broadcast live by the Higher Education Channel (HEC-TV) and streamed live on their website. A Mother's Day performance will be held at the Donald C. Bedell Performance Hall in Cape Girardeau, Missouri on Sunday, May 13, 2012 at 2:30 pm. Proceeds from the latter two shows will benefit the St. Louis Chapter of the Alzheimer's Association.

Each performance will be followed by an intermission, then a question and answer session with representatives of the Alzheimer's Association and key players in the ballet. An American Sign Language interpreter will be provided at each performance. ## *The UUSC Link*

The UUSC is an independent human rights organization, supported through the volunteer efforts and financial gifts of its members and supporters, and linked to UU congregations through local representatives. The four focus areas of its work include: *Rights in Humanitarian Crises; Civil Liberties; Economic Justice; and Environmental Justice.*

March 8 is *International Women's Day*. The original U.N. resolution for the day to end violence against women calls for the full implementation of the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW). UUSC sent a team of two women-advocates and U.S.-Sudanese Imam Mohamed Hagmagid to Darfur in early January, to train local imams and leaders around prevention of violence against women (VAW). The team, together with UUSC's Darfur partners, led two innovative multi-day workshops for 80 religious and community leaders on the dynamics of VAW, its family and community impacts, theological concepts for intervention and prevention, and the role of imams as agents of change.

On March 25, the Social Justice Group will lead the *Justice Sunday* service. This year's theme is "Justice is the Human Right to Water." UUSC partners with others world wide and in the U.S. in its work for the human right to water. For example, after an official 2011 mission to the United States, Catarina deAlbuquerque, the U.N. special rapporteur on the human right to safe drinking water and sanitation, reported great progress but raised serious concerns about discrimination and access to safe drinking water. With UUSC assistance, de Albuquerque held hearings in three states and Washington D.C.; spoke with local communities and government officials; and testified before the congressional Human Rights Commission. The U.S. administration responded to her report, in part, "We look forward to continuing to work with the special rapporteur to take concrete action to reduce the number of people without sustainable access to safe drinking water and basic sanitation." UUSC brings to our attention the book *Blue Revolution: Unmaking America's Water Crisis* by Cynthia Barnett. Barnett describes an illusion of water abundance and proposes the most important part of the solution is also the simplest and least expensive: a shared water ethic among citizens, government and major water users.

UUSC is working with our Coffee Project partner Equal Exchange in advocating for better certification of authentic fair trade. UUSC contends that the corporate, plantation model put forth by TransFair/Fair Trade USA is not authentic Fair Trade.
