The flowers are blessed during the ceremony, and the message reflects upon the flowers' symbolism. At the end of the service, each person brings home a flower other than the one that he or she brought.

## *The UUSC Link*

**The UUSC is an independent human rights organization, supported through the volunteer efforts and financial gifts of its members and supporters, and linked to UU congregations through local representatives. The four focus areas of its work include: *Rights in Humanitarian Crises; Civil Liberties; Economic Justice; and Environmental Justice.***

This month, I would like to share a portion of the Humanitarian Crisis program update:

“Keeping March 2013 elections peaceful in Western province of Kenya

“The Western province in Kenya was not marred by the kind of terrible violence that broke out after the 2007 Presidential elections. A UUSC partner, Kakamega Grassroots Initiative, KGI, played a big role in keeping peace in Western Province during the uneasy week leading up to the elections. Pastor Keta, the head of KGI, crisscrossed the province tirelessly on his motorbike or in rented buses with a core of interfaith leaders that he mobilized to stand up for peace.

“In December 2012, Keta trained a core group of leaders from different religions to raise their voices for peace. They in turn reached out to other faith leaders across religions to join their voices in this call. In January and February, they began traveling to villages and towns and eventually to the neighboring provinces, calling people together in the markets, in churches and in other village meeting places, working with people to keep peace with each other and not resort to violence. Seeing so many faith leaders of different religions and ethnic groups work together inspired the people of Western Province. Despite the tensions over the elections, they heeded the call, and peace reigned in Western province during and after the elections.”

Peace is possible!

*The Board of Trustees has reviewed and revised the Policy on Use of Facilities. Here is the new text. If you have any questions, please contact any member of the Board.*

## MVUUF Policy on Use of Facilities:

Approved by the MVUUF Board of Trustees on April 3, 2013

**To supersede policy approved by the MVUUF Board of Trustees December 6, 2006**

Approval for the use of the Fellowship building is necessary if the building is to be used for activities other than regularly scheduled Board-sanctioned activities (such as Sunday services, committee meetings, discussion or meditation groups). To obtain approval a member of MVUUF must request approval from each Board member and a majority of three Board members must approve the use of the building for the activity.

The Fellowship building shall not be used for any purpose inconsistent with the Fellowship's tax-exempt status. The Fellowship building shall be used in a manner consistent with the Principles and Purposes of the Bylaws of this Fellowship. A member of the MVUUF must be present during this approved activity, and said member must be responsible for the care of the building and any clean-up after the activity has concluded. A refundable deposit may be requested by the Board as a condition of approval of facility use. The deposit will be refunded in full if no damage has been incurred.
