## *The UUSC Link*

**The UUSC is an independent human rights organization, supported through the volunteer efforts and financial gifts of its members and supporters, and linked to UU congregations through local representatives. The four focus areas of its work include: *Rights in Humanitarian Crises; Civil Liberties; Economic Justice; and Environmental Justice.***

UUSC has issued a Statement on National Security Agency Surveillance. The statement focuses on concerns about civil liberties and says in part: “The leaks reveal surveillance programs with a scope that goes well beyond what had been publicly known until now.... The disclosure of these surveillance programs is the latest evidence of the ways in which the post-9/11 security state has curtailed civil liberties without adequate oversight. ... Defenders of the NSA surveillance methods currently under scrutiny cite national security as a legitimate rationale for what they see as a minimal invasion of private communications. It is possible to acknowledge a vested interest in our nation's security while also voicing concern about what appears to be an alarming lack of government oversight and a serious violation of the right to privacy....Accountability and transparency are central to ensuring a free press and a thriving democracy, and their absence in any society threatens everyone's civil liberties. As rights guaranteed to every individual, civil liberties provide protection from arbitrary intrusions and assure equal participation in government processes....UUSC has a strong commitment to ensuring that these rights are upheld as a central component of an open and democratic society. Over the coming weeks we will follow the developments regarding the NSA surveillance programs as we continue to work toward universal respect for civil liberties in the United States and abroad.”

## MVUUF Policy on POLITICAL ACTIVITY at the Fellowship

Approved by the MVUUF Board of Trustees on June 5, 2013

*In 2012, an audit team consisting of two accountants, members of the Carbondale Unitarian Fellowship, reviewed our Fellowship's financial records and procedures, and made ten recommendations. One of the recommendations is to develop "a written policy prohibiting the Fellowship from participating or intervening, directly or indirectly, in any political campaign on behalf of or in opposition to any candidate for public office." Violating this policy could result in the Fellowship losing its tax-exempt status. Therefore, the MVUUF Board of Trustees, on 6/5/13, approved the following Policy on Political Activity at the Fellowship. The policy is posted on the Fellowship News bulletin board and is available for review in the Policies and Procedures notebook. If you have questions or concerns, please contact any member of the Board of Trustees.*

The Mt. Vernon Unitarian Universalist Fellowship (Fellowship) both respects the separation of church and state, and affirms and promotes the right of conscience and use of the democratic process within our larger society. These two commitments can sometimes seem at odds.

The Board of Trustees of the Fellowship actively encourages nonpartisan programs and events that support informed participation in the democratic process. However, some activities are partisan and therefore not appropriate at the Fellowship. These include:

**Political Fundraising.** No fundraising for a political party or candidate will be permitted within Fellowship property.

**Political Endorsements.** Neither the Fellowship nor its lay or professional leadership speaking in the capacity of such leadership will endorse an announced or potential candidate for office, or a political party.

**Political Donations.** The Fellowship will not make donations or loans to political campaigns, parties, or candidates. The resources and facilities will not be used on behalf of a political campaign or candidate.

**Political Advertising or Signage.** Signs or other advertising for candidates or political parties will not be posted on Fellowship property. No Fellowship communication – the order of service, bulletin, UUMatters, or any other Fellowship publication – will include advertising for or endorsement of a political party or candidate for office.

**Targeted Voter Registration or Election Support Activities.** Any voter registration drive or “get out the vote” effort undertaken by the Fellowship or group(s) within the Fellowship must not be partisan.

**Political Labor.** The Fellowship will not organize groups to work for any political campaign or candidate.

**Distribution of Partisan Political Materials.** There will be no distribution of partisan political materials on the Fellowship property.

The Fellowship building shall not be used for any purpose inconsistent with the Fellowship's tax-exempt status.
