## Board Meeting Highlights

Our Board agreed by consensus for MVUUF to contribute \$25.00 monthly to [Lifeboat Alliance](#), a Mt. Vernon organization that provides shelter, food and training to homeless people. A basket or container will be placed on the table in the Fellowship Hall for additional contributions along with the basket for Angels on Assignment. The Board of Trustees also scheduled a Membership meeting for November 23 to vote in support of the ordination of Paul Oakley.

### *Membership Vote Unanimous to Ordain Paul Oakley*

Member Paul Oakley has studied and interned to become a UU minister since 2009. Congratulations on this next milestone towards UU ministry. As explained in last month's newsletter, in the UU tradition of democratic process in which "power lies with the people," the decision to ordain a UU minister is made by the membership of one or more congregations that know the minister and have experienced aspects of his ministry.

At the November 23 Membership meeting, MVUUF members voted unanimously to ordain Paul Oakley. MVUUF is the second congregation (of three congregations where Paul has served) to approve ordination. The Abraham Lincoln UU Congregation in Springfield has already done so, and the Carbondale UU Fellowship will vote at their membership meeting in January.



## *The UUSC Link*

**The Unitarian Universalist Service Committee is an independent human rights organization, supported through the volunteer efforts and financial gifts of its members and supporters, and linked to UU congregations through local representatives. The four focus areas of its work include: *Rights in Humanitarian Crises; Civil Liberties; Economic Justice; and Environmental Justice.***

***Action Updates:*** UUSC and the Unitarian Universalist Association (UUA) have released a joint statement announcing the [UUSC-UUA Ebola Epidemic Relief Fund](#), established to assist health organizations in Liberia and Sierra Leone, two of the countries most devastated by the epidemic. As with previous UUSC-UUA joint relief efforts, the funds will be distributed to groups working with communities that are neglected by other relief efforts. Donations to this special relief fund will be used to support community-based partners that will address the full continuum of care by strengthening established health centers, training new health workers, focusing on rapid case detection, and tracing patient contact. **Donations can be made online or by check** to UUSC, PO Box 808, Newark, NJ 07101-0808. Please write "Ebola Relief" in the memo line to designate your gift to the UUSC-UUA Ebola Epidemic Relief Fund.

Voters in four states — Alaska, Arkansas, Nebraska, and South Dakota — and three cities in California passed binding ballot initiatives that will [raise the minimum wage](#) for more than 609,000 low-wage workers. One more state (Illinois) as well as nine counties and four cities in Wisconsin passed nonbinding referenda that call on policymakers to pass legislation that would raise wages for over 1.1 million additional workers. The success of these ballot proposals, especially in more conservative states, builds momentum for an increase in the federal minimum wage and indicates that income inequality is a growing concern across the country.

A contingent from the Unitarian Universalist Association (UUA) and the Unitarian Universalist Service Committee (UUSC) participated in the People's Climate March in New York City on September 21. There, an estimated 400,000, including 1,500 Unitarian Universalists, took to the streets to demand that the world's leaders address the crisis of climate change. In the face of this historic threat to our existence on the planet, the UUA and UUSC are joining with the Unitarian Universalist Ministry for Earth, the Unitarian Universalist College of Social Justice, and the Unitarian Universalist Ministers Association in [Commit2Respond, a religious response to the crisis of climate change](#). Learn more at the Commit2Respond website.

## ***MidAmerica Board Statement on Ferguson***

*The Board of Trustees of the MidAmerica Region of the Unitarian Universalist Association issued the following statement in response to the call from our MidAmerica congregations and their ministers in the greater Saint Louis area.*

Our deep theology as a justice-seeking people calls upon us to engage this major civil rights work. We, the members of the MidAmerica board, are deeply committed to the work of anti-oppression, anti-racism, and multiculturalism. We stand on the side of love with the people of Ferguson as they seek justice in the case of the death of Michael Brown.

We see what is happening in Ferguson as part of a larger issue in our Region and all of America. It is about dehumanization, about racism, and about injustice. We note that we are all currently affected by the same culture of fear of difference that festers in Ferguson.

We encourage Unitarian Universalist congregations and religious leaders in the Mid-America Region to engage thoughtfully in the suggestions for action put forward by the Ferguson Response team of Saint Louis area ministers and Unitarian Universalist Association and UU Service Committee leaders.
