## *Tenth Anniversary—April 2006*

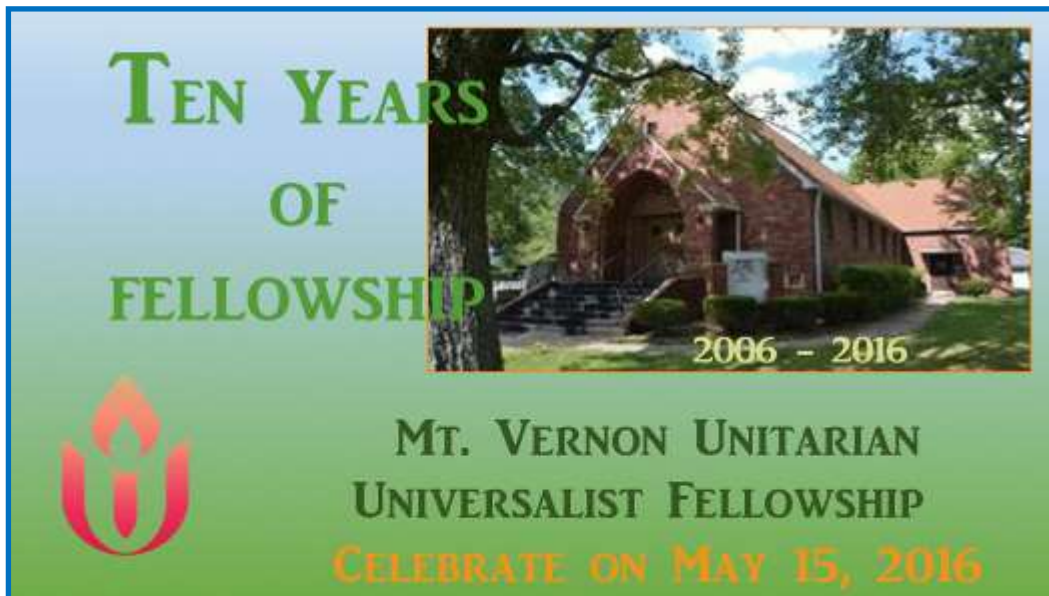
Paul Oakley provides this information about activities in April 2006:

“In April of 2006, we had a meeting of (call us what you will at that point) proto-members who voted to adopt the bylaws and legally organize. There was no legal organization until the week after that meeting so, technically, there were no members yet, although we did sign membership forms immediately after the meeting at which we adopted the bylaws. If you find my membership form, it is dated on the very first day that membership came into being, the same day as the meeting at which we voted to accept the bylaws and legally organize. Then in May of 2006 we had our first regular membership meeting for electing our first Board.”

That “very first day” was April 23, 2006. These are the first to sign membership forms on April 23, 2006:

# Open Minds

## ***April 20, 6:30 p.m. Climate Change 102***

Open Minds discussion on Wednesday, April 20 will center on Climate Change, as a second part of our two-month discussion. Climate Change 102 offers a more micro view. Leadership on these is Vito, Mike D and Roberta P.

The Social Justice Interest Group hosts the Open Minds discussion series on the third Wednesday of each month **at 6:30 p.m.** at the fellowship building, to encourage exploration and discussion of social justice and related issues. The series is open to the public.

## ***Being Environmental***

Being Environmental can start with gardening practices that promote compatibility with nature. One can look at native plants and trees first. It's becoming more difficult not to find an altered plant or cultivar. We're being told to buy the "new and improved" and disregard the old tried and true. Although the cultivars may not be as disease and insect-resistant as the original native plants/trees, they do attract our native insects, all of which play a vital role in continuing the cycle of life. There is still a place for cultivars in our gardens. They are beautiful and can help promote an interest in a special theme or type of plant. However, this increased disease and pest resistance often comes with decreased scent, color and perhaps, in the case of vegetables or fruit, taste. Starting from seed is a labor of love and the use of a good grow light or a favored directional window really help. If interested in buying starter plants, they are also becoming available. It all comes down to choices and there's not a bad one as long as we get to connect with our soil and our sun.

For those who might be experiencing ants inside the home, consider mixing borax crystals with sugar and water and setting around their favorite places with cotton balls or something similar. In a short time, this should hopefully decrease and eliminate the problem. They don't like cinnamon either. It doesn't harm them perhaps as much just drive them back outside. Remember this is for inside the home. If they're outside, that's their natural home.

Rev. Scott Aaseng , director of the recently formed UU advocacy Network of IL (UUANI ) recently reached out to leaders of 22 Illinois UU congregations to get a sense for the top concerns of UUs around the state. As part of the process, Rev Bill Sasso visited MVUUF in January and met with interested people from our Fellowship.

Later in January, UUANI identified these guiding concerns when selecting areas of focus:

- **Grounding:** Does it reflect the deeply held values and broadly shared interests of people in our congregations?
- **Accountability:** Are we acting in relationships of solidarity with those most impacted, particularly those most marginalized?
- **Fit:** Does it match our capacity to act effectively, and does it strategically build our capacity?
- **Opportunity:** Is there a political opportunity to achieve meaningful results?

The results were clear, and UUANI agreed to focus on the following major issue areas

- **Environmental Justice:** Reflecting our UU respect for the interdependent web, and in partnership with the Illinois Clean Jobs Coalition (which includes strong representation from low-income people of color), we will continue to push for strong implementation of the EPA Clean Power Plan through the [IL Clean Jobs bill](#).
- **Economic Justice:** Reflecting our UU commitment to justice, equity and compassion, and in partnership with the Responsible Budget Coalition (which also includes strong representation from low-income people of color), we will continue to push for a graduated state income tax ([Fair Tax](#)) with higher lower rates for lower incomes and higher rates for higher incomes. We will also continue to support various efforts to fully fund the state budget.
- **Racial Justice:** Reflecting our UU commitment to the inherent worth and dignity of every person, we will work to build partnerships between UUs and organizations representing people of color in communities around the state, expressing our solidarity by listening to and following the lead of these organizations. In addition to supporting various local efforts, we will advocate in partnership with the UU [Prison Ministry](#).

UUANI seeks to empower Illinois UUs to do the work of justice in our state. You are invited to join the [Facebook group](#) for action updates and ongoing conversation.

### ***IL Clean Jobs Bill Advocacy***

Working with UUANI (UU Advocacy Network of Illinois), MVUUF Social Justice Interest Group has action cards in support of the **Clean Jobs Bill**, addressed to Gov. Rauner and IL EPA director Lisa Bonnett. The cards and **Clean Jobs Factsheet** are on the table at back of the Fellowship hall, for those interested. We will assure that they'll be delivered in time (Continued on page 6)

to make it to the legislators later in April. The UUANI position:

“The Clean Power Plan—the first-ever federal plan to limit dangerous carbon pollution from power plants— presents an unprecedented opportunity for Illinois to improve our health, environment, and economy. As an Illinois resident, I support a strong and just implementation of the **Clean Power Plan** through the **Illinois Clean Jobs** bill. The benefits of this plan including clean energy development, lower electric bills, and pollution reduction should made available throughout Illinois, and especially in vulnerable communities that have had to deal with the brunt of fossil fuel pollution.”

## ***FLINT WATER CRISIS INFORMATION***

Dear Good People,

First and foremost, the crisis is not exaggerated. The pipes are corroded, the water is contaminated. Distribution of water and water filters is a welcome but totally inadequate response. Fixing the now ruined infrastructure is both necessary and costly.

Importantly, testing has clearly shown elevated levels of lead in the systems of Flint children. Know this: the effects of lead poisoning are permanent and affect the cognitive, physical, regulatory, social, and behavioral aspects of the individual causing, learning, behavioral, attentional, and physiological problems, potentially for the rest of one's life.

For children, treatment consists of immediate riddance of the lead source, healthy diet, increases in Vitamins C, calcium, zinc, phosphorous and iron; educational, language, hearing, behavioral and mental health resources and assistance.

Please spread the word. Test the water in your area. Be mindful of the toxic materials we are placing into our environment as a result of the plastic and chemicals being utilized.
