## Statement of Support

As an expression of MVUUF's continuing support of member Paul Oakley on his journey to be credentialed as a UU minister, the co-chairs of the Board of Trustees have signed a *Statement of Congregational Sponsorship* on his behalf. Paul was admitted to candidacy for UU ministry in March of this year. The Ministerial Fellowship Committee requires that every candidate for UU ministry receive the formal sponsorship of a UU congregation.

Paul met with the Board of Trustees at its regular April meeting to present his request, and to answer questions from Board members. Paul explained that he has lots of work to complete yet before he meets with the Ministerial Fellowship Committee, but sponsorship is a necessary step. By signing the Statement of Congregational Support, the members of the Board affirm that we have confidence in Paul's potential and suitability for UU ministry. We are saying that, with further training and education, he has a good chance of developing the traits necessary for successful ministry.

MVUUF member Adam E. Stone's spoken-word ballet "A Life Unhappening," which examines the impact of Alzheimer's disease on three generations of one woman's family, will be performed three times in our area.

A special preview performance will be held at Shryock Auditorium in Carbondale, Illinois on Friday, May 4, 2012 at 7:30 pm, with proceeds from the performance to benefit the Greater Illinois Chapter of the Alzheimer's Association. The World Premiere performance will be held at the Blanche M. Touhill Performing Arts Center in St. Louis, Missouri on Friday, May 11, 2012. A wine and cheese reception will begin at 6:30 pm, with the performance to follow at 7:30 pm. The performance will be broadcast live by the Higher Education Channel (HEC-TV) and streamed live on their website. A Mother's Day performance will be held at the Donald C. Bedell Performance Hall in Cape Girardeau, Missouri on Sunday, May 13, 2012 at 2:30 pm. Proceeds from the latter two shows will benefit the St. Louis Chapter of the Alzheimer's Association.

Each performance will be followed by an intermission, then a question and answer session with representatives of the Alzheimer's Association and key players in the ballet. An American Sign Language interpreter will be provided at each performance. ## The UUSC Link

The UUSC is an independent human rights organization, supported by the volunteer efforts and financial gifts of its members and supporters, and linked to UU congregations through local representatives. The four focus areas of its work include: Rights in Humanitarian Crises; Civil Liberties; Economic Justice; and Environmental Justice.

Restaurant work is one of the fastest growing industries in the US. Yet restaurant workers are among the most poorly compensated American employees. The following is from an email sent by Kara Smith, Associate for Grassroots Mobilizing (UUSC), to UUSC volunteers in April.

Keith Jones is an African American server who was hired at Capital Grille in Maryland when it opened. He was lauded for his excellent service. However, when management changed hands and sought to "clean up" the restaurant, they fired Jones and almost all the other people of color who were servers, saying they did not "meet Capital Grille standards."

These are the working conditions reported by employees of restaurants in the Darden Restaurant group, which owns and operates approximately 1,900 restaurants worldwide, including Capital Grille, Red Lobster, Olive Garden, and Longhorn Steakhouse. Darden's sales total more than \$7 billion annually. Yet Darden restaurant workers are paid as little as \$2.13 per hour for tipped employees and \$7.25 per hour for non-tipped employees, with no paid sick days.
